Canaan Motor Club Rules

GENERAL RULES

- Vehicles over 90 dB may not be started prior to 8:30am. At no time may vehicle noise exceed 96 dB without prior consent
- Vehicles below 90 dB may not be started prior to 7:00am
- Canaan Motor Club reserves the right to decline Facility access to any individual or vehicle for any reason
- Canaan Motor Club shall have the right at any time, in its sole discretion, to eject from its Premises any person for conduct which may be unsafe, rude or may otherwise diminish the enjoyment or safety of others on the Premises
- The operator of any non-Event registered motor vehicle on the Premises must be over 18 years of age, hold a valid driver's license and have insurance covering that motor vehicle
- Children under the age of 18 must be accompanied by an adult while on the Premises and kept under adult supervision at all times
- Children under the age of 18 are not permitted to drive golf carts or any motorized recreational vehicles at Canaan Motor Club
- All pets are to be leashed and supervised at all times
- All pets must be cleaned up after
- Alcoholic beverages are not permitted in the paddock and pits until after all track activities have concluded for the day
- Vehicles, equipment, trucks or trailers may be brought into or left on the Premises only during the hours of 7:00am – 5:00pm on Weekend Event Date or 9:00am – 4:00pm on Weekday Event Date, unless Early Access has been arranged for Weekend Only Event Date(s), in which case, vehicles, equipment, trucks or trailers may be brought on Premises at 7:00pm the evening prior to the Event Date
- Any skating systems, skate boards, rollerblades or bicycles will not be allowed to operate on the Premises of Canaan Motor Club, including the Facility or on access or paddock road
- Renter has no right to place any advertising on Canaan Motor Club premises (paid vendors are exempt)
- Canaan Motor Club is a smoke-free Facility
- Firearms and fireworks are prohibited on Canaan Motor Club property at all times
- All access roads must be kept clear for emergency vehicle access at all times
- No electrical cords may cross any roadway or access area where vehicles or pedestrians travel

CARE OF PREMISES

- Open wood or coal fires are not allowed anywhere on Premises. Renter assumes responsibility for other fires (small gas grills, etc.) which are permitted only in the Camping Area, should Renter authorize their use
- Renter is responsible to pay for all damage to the Premises incurred in connection with Renter's Event, including but not limited to: fences, guardrails, walls, etc.
- Renter is responsible to pay for all damage to asphalt in the paddock or other areas incurred in connection with Renter's Event, including but not limited to holes or depressions caused by tent supports, trailer supports, or jacks
- Renter is responsible for all asphalt surfaces throughout the Premises resulting from spillage or leaking of any fluids, including but not limited to: oil, hydraulic fluid and antifreeze – **NO FUELING ON PAVED SURFACES**
- Renter shall ensure that its employees, agents, contractors, vendors, customers, and guests take with them all broken vehicle parts, batteries, scrap metals, tires, etc. Canaan Motor Club will invoice the Renter the cost of removal of any such items left on Premises after the Event
- CMC is a "take out what you take in" facility and the dumpsters are not for Renter's use. To avoid trash removal fees, please take your trash with you when you leave. Example: CMC charges \$50.00 for the removal of one tire
